# **Cookie Policy**

The Cookie Policy ("Policy") suggests that Webs.li and projects related to Webs.li – <u>Lnd.li</u>, <u>Donate.re</u> can openly about the use of your information. The following information explains in what ways and when we use cookies on the site. In the Policy regulations, we will refer to to Webs.li and our other sites (Lnd.li, Donate.re) that operates as Websites and are related to the Policy

The Webs.li and all marketing partners, affiliates, analytics, and services providers use cookies with the purpose to guarantee that everyone using "Websites" has the best experience possible.

### What Does the Term Cookie Mean?

Cookies are tiny text files sent by a server which are saved on the customer's endpoint device (for example a computer or a smartphone). They are used to store information as well as analytical and statistical data necessary for proper operation of the service and for adapting the shop to your preferences. Cookies have no impact on your device and they do not change the configuration of the endpoint device.

A cookie is a small file made up of numbers and letters. It's used to store information on your device as you visit our website. There are two types of cookies differentiated:

- Session cookies that are used during a single site visit and either removed after the browser is closed.
- Persistent cookies that are saved on the device for some time during the repeat visits.

## Why Do We Use Cookies

Cookies (or similar technologies) are used whenever you use our services through the Web-site. Cookies are saved on your device depending on your preferences and device settings, for example web browser settings.

Our website uses cookies in order to differentiate you from the rest of our visitors. We use cookies in order to ensure that you can get the best browsing experience possible. Thanks to cookies, we can improve our website and make your browsing sessions more enjoyable. The cookies are set as you take different action on our site. For example, some of them are used when a user opens our site, others are activated when you take some actions. For example, this may be "liking" our content or sharing it on social media.

# Do cookies store personal data?

The stored information does not include any personal data which could directly identify you. Some of the information may become personal data in combination with data obtained as a result of your registration on our website.

Consequently, <u>Privacy policy</u> provisions regarding Personal Data apply in this respect, especially as regards the right of data subjects.

## What Cookies Do We Use? For What Purpose?

This is the complete list of cookies that we use on our websites:

- Strictly necessary cookies used to operate our website for technical purposes.
- Analytical/performance cookies used to collect general information about users who reach our site, as well as their behavior while browsing our web pages. This helps us to improve performance of our site. For example, performance cookies help us make different pieces of content more findable. All information is 100% anonymous.

- Functionality cookies used to discover you, when you return to our website. Using this information, we can provide you with a more personalized browsing experience. For example, you will notice us greeting you by name, saving your preferences (like language, region, location, and account name). Also, we can provide you with suggestions on items that meet your preferences. As soon as you register on our website or fill in any of the forms provided on it, we will use cookies to remember your details during current visit and all following visits (provided that cookies are not deleted). We do not use cookies to track visitors' behavior on other sites.
- Targeted cookies used to save information about your visit to our website, as well as, actions that you took while browsing its pages. This includes tracking links that you followed and the pages you visited. The respective information will be used for advertising purposes. We will display ads that are the most relevant to your preferences. Please keep reading further to see more details about this type of cookies, as well as how to opt out.

### Can I Disable Cookies? How?

You can enable and disable cookies in your browser settings. Visit the <u>site</u> to learn how to opt out of being tracked by Google Analytics across all websites that you visit.

## How to Manage Cookies in Web Browsers on PC?

Follow these instructions in order to enable cookies in your web browsers.

## Google Chrome (<u>information</u>)

- 1. Navigate to the top of the browser window. Click "Tools" > "Settings".
- 2. Choose "Show advanced settings". Scroll down until you reach the "Privacy" section, choose "Content Settings".
- 3. Click "Allow local data to be set", in order to accept first-party cookies, select "Block all third-party cookies without exception".

### Microsoft Internet Explorer (information)

- 1. Navigate to the top of the browser window. Click "Tools" and choose "Internet Options". Click the "Privacy" tab next.
- 2. In order to use cookies in your browser, the level of your privacy should be set to Medium or Lower.
- 3. Setting it above the medium level, the cookies won't be used.

#### Mozilla Firefox (information)

- 1. Choose "Tools" at the top of the browser window. Select "Options".
- 2. Click on the "Privacy" icon.
- 3. Select "Cookies" and click "Allow pages to create a cookie."

#### Mozilla and Netscape on OSX

- 1. Click "Mozilla" or "Netscape" at the top of the browser window. Click "Settings".
- 2. Scroll down to the "Cookies" below "Privacy & Security".
- 3. Click "Allow cookies only to the original site."

### Safari (information)

- 1. Find the gear icon at the top of the browser window. Choose "Settings".
- 2. Click the "Privacy" tab and choose "Disable the use of cookies by third parties and advertising cookies."
- 3. Click "Save".

## How to manage cookies on your Mac

Consider the following steps in order to enable cookies on our website.

#### Safari on OSX

- 1. Click "Safari" at the top of the browser window. Click "Settings".
- 2. Select "Privacy" and then click "Enable cookies."
- 3. Choose "Only the pages you have visited."

## Microsoft Internet Explorer on OSX (information)

- 1. Find "Explorer" at the top of your browser winder. Choose "Settings".
- 2. In the "Received Files", scroll down to the "Cookies" section.
- 3. Click "Do not ask."

#### Opera (information)

- 1. Click "Menu" on top of the browser window. Click "Settings".
- 2. Choose "Options" and click "Advanced".
- 3. Chose "Enable cookies."

Information about cookie management on a mobile phone or another mobile device can be found in the user guide/manual of a particular phone or mobile device.

## What Are the Results of Cookies Deactivation?

Disabling cookies that are necessary for website's proper operation, the web page won't load either. Those are the cookies that are intended to enhance your site browsing experience.

Disabling cookies that remember your preferences or analytics, we won't be able to provide you with the relevant information. If you disable all cookies (including the essential ones), then you won't be able to access all parts of our website. However, disabling cookies won't deactivate web beacons and other trackers. Still, the web beacons' functionality will be limited.

Deletion of cookies does not mean that the Controller has deleted the Personal Data obtained through cookies.

## Changes to the Policy

We may bring changes to the Privacy policy or Cookie Policy once in a while. This may happen as a result of the changes in the law or as a result of the changes in our services. All of such changes will be added to this statement. So, check it out from time to time.
